Sesswick Community Council

Introduction and Context

Sesswick Community Council is a small, rural parish in Wrexham County Borough, covering the village of Cross Lanes, the hamlets of Pickhill and Bedwell and the township of Royton. All are approximately three miles from Wrexham.

The vast majority of the local- government services impacting biodiversity are provided by the county council rather than at community council level.

Sesswick Community Council is not responsible for any green spaces. There are no planters or hanging baskets in the parish which are maintained by the community council.

Per the last census in 2011, the population of Sesswick was 609. The precept for the 2019/ 2020 financial year was set at £3,000.00.

Due to its small size, Sesswick Community Council currently does not fall under the scope of the Well- Being of Future Generations (Wales) Act 2015 and consequently does not produce an Annual Report detailing its activities during the preceding twelve months.

What has worked well?

Planning consultations have flagged environmental and biodiversity concerns to the local planning authority

What have the barriers been?

Extremely limited finances.

Lack of expertise and time available at the community council level to identify changes needed or best practice

Resources at Wrexham Country Borough Council on these matters have been reduced considerably due to cutbacks

What will you change?

All decisions taken by the community council will take biodiversity and ecosystems into account as a key determinant.

The council will try to become more proactive with the limited remit in which it operates, working with other bodies where possible.

How and when will the section 6 duty be monitored, and the section 6 plan reviewed?

This obligation will be monitored by the community council's officer and Chairman on an ongoing basis and reported back to the full council at appropriate points in the bi-monthly meetings.

The section 6 plan will be reviewed in light of these reports and any other evidence or information that is made available to the Council.

At the time of this report's publication, there is no specific time or date set for the plan to be reviewed. However, this will be done by November 2022 at the latest, or earlier if deemed necessary (if required by legislation or the current plan becomes obsolete).
